III. UNFINISHED BUSINESS

A. Update on revision process for K.A.R. 66-9-7

Ms. Lopez, Director, and Ms. Easter met with two Assistant Attorney Generals regarding the process for moving forward as the regulations cannot adopt another organization's policy or guidelines. Ms. Lopez has contacted NCARB to gain better insight into the process of editing the NCARB AXP Guidelines or Certification Guidelines. Ms. Easter reports that Ms. Lopez will be editing the guidelines in order to form a Board policy which K.A.R. 66-9-7 will be revised to relay to.

IV. NEW BUSINESS

- A. Society updates/reports of national meetings or committees/discussion of national issues
 - 1. ASBOG- Updates- Henthorne

Mr. Henthorne reported the success of the ASBOG Annual Meeting held in Lawrence, KS in October. There has been a significant increase in the national number of examinees since ASBOG has been focusing on outreach efforts.

Mr. Hoffman reported the launch of the A.R.E. 5.0 on November 11, 2016 and the successful transition of approximately 6,500 examinees. A cut score will be set in the upcoming months as enough test results are queried. NCARB has recognized a new Mutual Recognition Arrangement between the United States, New Zealand, and Australia that enables architects to earn reciprocal licenses abroad. There is a Model Law update in progress and a regional meeting has been set in March that Mr. Hoffman plans to attend.
