I. MINUTES

- A. Approval of minutes of the September 8, 2023 meeting (previously distributed).

By a motion of Mr. Louis, seconded by Mr. Johnson, the committee voted to approve the minutes.

II. ADDITIONS OR ADJUSTMENTS TO THE AGENDA

III. APPLICATIONS

- A. Discussion of applications not approved by letter ballot.

1. Ballot 24-107 Reinstatement (ARCH) - Faulkner
 - a. Marianne Remboldt – CEUs

By a motion of Ms. Faulkner, seconded by Mr. Johnson, the committee voted the applicant needs an additional 20 HSPW CEUs.

2. Ballot 24-114 Arch Reinstatement – Johnson
 - a. Douglas Loyd – CEUs

By a motion of Mr. Johnson, seconded by Ms. Faulkner, the committee voted Mr. Loyd completed more than the allowed maximum 10 hours per day CEU limit. Mr. Loyd was advised in person no more than 10 hours can be allowed in a 24-hour period. Mr. Loyd needs an additional 11 hours, 4 of those 11 hours needing to be HSPW.
