B. Procedures for SE Applications KSBTP PE PS MINUTES, JULY 14, 2017

The Committee discussed the process for approval of applicants to sit for the SE exam. Applicants may request to sit for the SE in Kansas by submitting a letter to the Board. They are not required to be a PE in KS or any other jurisdiction prior to approval. Once scores are received by the Board staff will send a letter indicating pass or fail. If an applicant passes the SE and wishes to be licensed as a PE in KS they will be required to submit an Application for Exam or Comity.

C. PE Chemical – transition from paper to CBT

The PE Chemical exam will transition to Computer Based Testing in January. As such the Board needs to revise policies and procedures related to the application process and due dates to accommodate for a year-round exam schedule. Mr. Erickson and Dr. Hayter will serve on a committee to assist in developing policies and procedures related to the application process and due dates for applicants for the PE Chemical exam.
