B. PE Chemical – Transition to CBT

PE Chemical Transition Task Force recommended an addition to the PE License by Exam application (attached) to outline the process for applying for the PE Chemical exam. By motion of Mr. Graham seconded by Haverkamp, the Committee voted to approve the recommended addition.

C. Procedures for Comity/MLE Applicants

By motion of Mr. Graham seconded by Mr. Bowersox, the Committee voted to revise the procedures for Comity and MLE PE applicants. Both Comity and MLE PE applicants will be required to complete entire application.

V. NEW BUSINESS

A. Application for Pre-Approval of Continuing Education Offering – Nettleman Land Consultants, Inc.

By motion of Mr. Graham seconded by Haverkamp, the Committee voted to direct Ms. Lopez to respond to Mr. Nettleman that the Board only provides pre-approval for continuing education courses related to Kansas Minimum Standards for Boundary Surveys and Mortgage Title Inspections Standards of Practice.
