**I. MINUTES**

By motion of Mr. Wimmer, seconded by Mr. Laurino, the Committee voted to approve the minutes of the July 20, 2018 meeting. Mr. Johnson and Ms. McMullen abstained from the vote due to absences at the July 20, 2018 meeting.

**II. APPLICATIONS**

**A. Discussion of applications not approved by letter ballot.**

**1. Ballot 19-08 – Henthorne**

**a. Daniel Robinson – Disciplinary**

By motion of Mr. Henthorne, seconded by Ms. McMullen, the Committee voted to approve Mr. Robinson's application.

**2. Ballot 19-22 – Wimmer**

**a. John Tolson – Disciplinary**

By motion of Mr. Wimmer, seconded by Ms. McMullen, the Committee voted to approve Mr. Tolson's application.

3. Ballot 19-36 – Wimmer

a. Jessica Fisher – Reinstatement

By motion of Mr. Wimmer, seconded by Mr. Laurino, the Committee voted to deny Ms. Fisher's application and directed Ms. Easter to include correspondence with the notice of denial that requires Ms. Fisher to complete new continuing education hours before re-applying.

**III. UNFINISHED BUSINESS**

A. Revisions to Architect Regulations K.A.R. 66-9-7, K.A.R. 66-10-1, K.A.R. 66-10-3

Ms. Easter relayed that KSBTP is waiting for official approval notices to arrive from the Attorney General's office for K.A.R. 66-9-7 and K.A.R. 66-10-3. Ms. Andaya presented current revisions to K.A.R. 66-10-1.

By motion of Mr. Laurino, seconded by Mr. Wimmer, the Committee voted to amend subsection (a) of K.A.R. 66-10-1 by replacing "... a licensed architect..." with "... an architect..." and granted authority to Board staff to make further changes to the regulation as necessary for Attorney General's Office approval.

**IV. NEW BUSINESS**

A. Society updates/reports of national meetings or committees/discussion of national issues

1. ASBOG

Mr. Henthorne reported he has recently traveled with the president of ASBOG to Maine and New Hampshire in an outreach effort to better communications with their state boards regulating professional geologists. Mr. Henthorne, Mr. Johnson, and Ms. Lopez will ask the Board for approval to attend the ASBOG Annual Meeting that will take place in Monterey, CA October 30 – November 3, 2018.

2. CLARB

Ms. McMullen reported CLARB's Annual Meeting will take place in Toronto in September 27 – 29, 2018; She plans to co-present at the annual meeting as a member on the Committee of Nominations. In addition, Ms. McMullen has been invited to speak at Iowa State University regarding state licensure for landscape architects and discussed the potential to present to Kansas universities in the future.
