IV. APPLICATIONS

A. Discussion of applications not approved by letter ballot.

1. Ballot 22-59 - Ornelas

A. Zachary Shirk – Education

VI. NEW BUSINESS

A. Society updates/reports of national meetings or committees/discussion of national issues

1. ASBOG – Louis

Mr. Louis advised he attended the ASBOG annual meeting in Little Rock Arkansas October 26-28, 2021. ASBOG anticipates computer-based testing to go live in 2023. There will be a spring summit in Albany, NY and next year's annual conference will be held in North Carolina.

2. CLARB – McMullen

Ms. McMullen is president elect of CLARB for this upcoming year. She explained CLARB is working on a strategic road map for licensure with CLARB 2.0. They are seeing the number of candidates leveling out and are re-evaluating by also looking for alternate paths to licensure.

3. NCARB – Johnson/Ornelas

Ms. Ornelas shared she attended a committee summit a few weeks ago. There is a Board Meeting at the end of January 2022, regional summit in March 2022 in Charlotte, and the next annual conference in June 2022 in Austin, Tx.

B. Geology Taskforce Discussion

Mr. Louis gave an update on the taskforce and advised a lot of discussion has been held. He stated they have met three times and there has always been a lot of input and feedback from all the involved parties. Mr. Louis explained they are working towards putting together a list of core criteria not just individual class names for board members and applicants alike to use. This list would contain class criteria an applicant must complete to gain licensure from the board as it pertains to Geology.
