### **IV. NEW BUSINESS**

#### **A. ABET proposed revisions to EAC Criteria 3 and 5**

The Committee directed Ms. Lopez to submit feedback indicating that the Board is in favor of the proposed changes to EAC Criteria 3 and 5.

#### **B. Clarification on requirement for Intern Certificate to take PE or PS exam**

There was discussion regarding whether or not the Intern Engineer Certificate is a required prerequisite before applying to take the PE exam as indicated on the KSBTP website. The Committee directed Ms. Lopez to remove this information from the website as the EIT Certificate is not required before applying to take the PE exam.

#### **C. NCEES Service Awards**

The Committee directed Ms. Lopez to work with Mr. Bowersox and Mr. Graham to submit a nomination for Richard Hayter for the NCEES Distinguished Service Award.

#### **D. Kansas State Specific Exam Policy Regarding Timing of Re-Takes**

The Committee discussed current KSBTP policies regarding Kansas State Specific exam re-takes. A candidate may take the exam up to three times per year (once every three months). After the third exam, candidates must receive approval from the Board and must layout one exam period.

#### **E. Washington Accord**

By motion of Mr. Bowersox, seconded by Mr. Brosemer, the Committee voted to create a policy that treats CEAB degrees like ABET Accredited degrees when applying for Comity. Mr. Graham will conduct more research on other countries under the Washington Accord and report back at the February meeting.

#### **F. Use of "Engineer" on business cards after passing FE**

The Committee discussed the use of the term "engineer" by individuals who have successfully passed the FE exam. "Professional Engineer" may be used by individuals who have passed the FE only to identify themselves and should not be used to market services or to hold oneself out to be capable of offering services.
