

IN THE MATTER OF ALBERT P. HERMANS, P.E.

Summary:

Albert Hermans holds engineering licenses in the states of Oklahoma, Minnesota, Missouri and Kansas. In 2008, Mr. Hermans submitted his application for renewal of his Kansas license and in so doing failed to advise the Kansas State Board of Technical Professions that he had been disciplined by the Missouri Licensing Board. Subsequently, in 2012, when he again applied to renew his engineering license in Kansas he revealed that he had received discipline regarding his Minnesota engineering license as a result of having been previously disciplined in the State of Missouri. Although Mr. Hermans ultimately revealed in 2012 that he had been disciplined in 2008 by the Missouri Licensing Board, he had obtained his Kansas license renewal in 2008 while failing to report the 2008 Missouri discipline.

Board Action:

Following the completion of an investigation, it was determined that Mr. Hermans had failed to advise the Kansas State Board of Technical Professions that he had been disciplined by the Missouri Engineering Licensing Board when he submitted his application for renewal of his Kansas license in 2008. The Board and Mr. Hermans resolved the matter by way of a Settlement Agreement and Consent Order in which he admitted his failure to report the discipline imposed by the Missouri Board and as a result thereof he agreed to pay a fine in the amount of \$500.

Status:

Mr. Hermans has fully complied with all of the terms and conditions of the Settlement Agreement and Consent Order in this matter and the case file has been closed.

IN THE MATTER OF ANDREW P. TANKING, L.S.

Summary:

In May 2010, the Complaint Committee of the Kansas State Board of Technical Professions received a letter from the Chairman of the Kickapoo Tribe in Kansas expressing concerns about surveys performed on the Prairie Band Pottawatomie Reservation. According to the Tribe Chairman, the errors were reported to the Tribal Counsel by George Winter, a BLM Surveyor. As a result of receiving that letter and other documents relating thereto, the Board's Complaint Committee directed that an investigation be conducted by one of the Board's licensed land surveyor investigators.

Board Action:

Following the completion of an investigation, it was the investigator's opinion that Mr. Tanking had deviated from acceptable land surveying practices and/or the minimum standards for boundary surveys in performing the surveys at issue.

As a result of the foregoing determination, the Kansas State Board of Technical Professions and Andrew P. Tanking entered into a Settlement Agreement and Consent Order which included the following:

The Respondent admits that he has deviated from acceptable land surveying practices and/or the minimum standards for boundary surveys in performing the surveys referred to above.

Respondent further agrees to the following:

1. The Respondent shall immediately conform his land surveying practices to generally accepted land surveying practices in the State of Kansas and to the minimum standards for boundary surveys as adopted by the Kansas State Board of Technical Professions in K.A.R. 66-12-1.
2. Respondent shall perform resurveys of each of the referenced surveys in question

which will depict all elements necessary to the survey in a manner that will conform to the Kansas minimum standards for boundary surveys. Said resurveys shall be conducted and completed within 12 months of the date upon which respondent signs the Settlement Agreement and Consent Order and they shall then be submitted to the Complaint Committee of the Board for said Committee's review no later than 30 days following their completion.

3. The Tanking survey for the Bureau of Indian Affairs dated August 15 – 16, 2005 shall be corrected to coincide with the Dependent resurvey R of Section 1, Township 4S, Range 15E, which is dated April 12, 2010 and was performed by George Winter, Cadastral Surveyor. This survey also affects Section 12, Township 4S, Range 15E. The subsequent corrected survey and pertinent references shall be filed for record within 12 months of respondent signing this agreement.

4. The survey for Steve Brady, dated August 6 – 15, 2008, in Section 1, Township 4S, Range 15E should also be corrected with the revised survey and references being filed for record. The errors which occurred with regards to this survey are as follows:

A. Research & Investigation

Failed to find and/or utilize Brown County Surveyor's records which would have determined the positions of section and quarter-section corners.

Failed to show collateral evidence (fences, stones, roadways and possession lines) on face of survey.

B. Conduct of Survey

Failed to thoroughly search for necessary controlling monuments & other physical evidence.

Failed investigate possible parol evidence supporting positions of obliterated control monuments and take necessary oaths.

Failed to take necessary measurements to analyze and evaluate evidence.

Failed to check measurements and computations to satisfactorily verify the initial field work.

Failed to locate relevant lines of possession.

Failed to evaluate the evidence and apply proper theory of location in accordance with statutes and/or precedents in determining the position of all corners to be established or re-established.

Failed to maintain pertinent information, measure-

ments and observations made in the field during the course of the survey in a manner that is intelligible to another surveyor.

Failed to follow K.S.A. 19-140-, 19-1411, 19-1412 and 19-1423.

C. Plat or Certificate of Survey

Failed to note all found or set monuments and evidence of possession beyond the surveyed premises on which establishment of the corners of the surveyed premises are dependent.

Failed to note the character or type of observed evidence of possession and the location of such evidence in relation to the surveyed boundary lines.

Failed to provide sufficient data to clearly indicate the theory of location applied in finalizing the locations of the corners, any data at variance with this theory of location and sufficient data to allow the facile retracement of all pertinent lines and points shown on the plat.

5. Once corrected the surveys must be filed for record.

6. Any future surveys performed by respondent must be sent to the Kansas State Board of Technical Professions for a review for a period of 6 months commencing upon the date the Settlement Agreement and Consent Order is approved by the Kansas State Board of Technical Professions.

7. The surveys in question must be corrected and completed in compliance with statutes, rules and regulations and must conform with the 2009 Manual of Surveying Instructions of Cadastral Surveys.

8. Respondent shall take 8 additional professional development hours (pdh) within 12 months of signing this Settlement Agreement and Consent Order over and above the otherwise required 30 hours of professional development hours (pdh).

9. Respondent shall be assessed and pay all expenses of the Board including attorney fees and investigation costs incurred in the investigation and prosecution of this matter and a civil fine in the total amount of \$5,000.00. Said fine and costs should be paid to the Kansas State Board of Technical Professions no later than 30 days following the date of approval of the Settlement Agreement and Consent Order by the Kansas State Board of Technical Professions.

10. Respondent shall be responsible for all expenses incurred by him in performing the resurveys referenced above.

Disciplinary Action, continued

Status:

Mr. Tanking has paid the fine imposed in the amount of \$5,000, which is the maximum that can be assessed for a first offense. Mr. Tanking is in the process of complying with the remaining terms and conditions of the Settlement Agreement and Consent Order.

Licensure Recognition Ceremony To Be Held February 22, 2013


