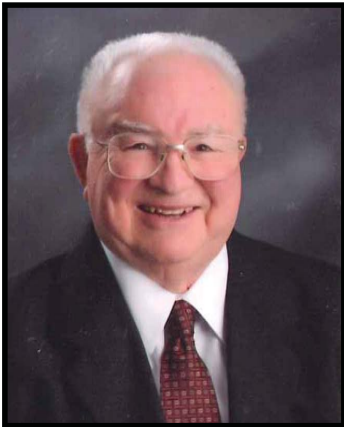

## IN THE MATTER OF STEVE PETTY AND FOUNDATION KING, LLC

**Summary:** In July and October 2013 two separate complaints were filed by the Kansas State Board of Technical Professions alleging that Steve Petty and Foundation King, LLC had engaged in the unlicensed practice of engineering in the State of Kansas.

**Board Action:** This matter was set for a formal hearing before a hearing panel. Following the formal hearing the panel entered a final order containing the following terms:

1. Steve Petty and Foundation King, LLC were ordered to pay a total fine and costs of \$5,000.00.
2. As a result of that action by the Board and Mr. Petty's failure to pay the \$5,000.00 amount, the Board filed a petition for Civil Enforcement of the Agency Action pursuant to the provisions of K.S.A. 77-624 in the District Court of Shawnee County, Kansas.
3. Mr. Petty and Foundation King filed a counterclaim against the Board requesting, in part, that the court take no action on the Board's claims.
4. The Board responded to that request by way of a motion for summary judgment against Mr. Petty and Foundation King, LLC

**Status:** Thereafter, on July 8, 2016, the Court entered its Memorandum Decision and Order in which it granted the Board's motion for summary judgment in the amount of \$4,850.00, and dismissed the counterclaim filed by Mr. Petty and Foundation King, LLC.

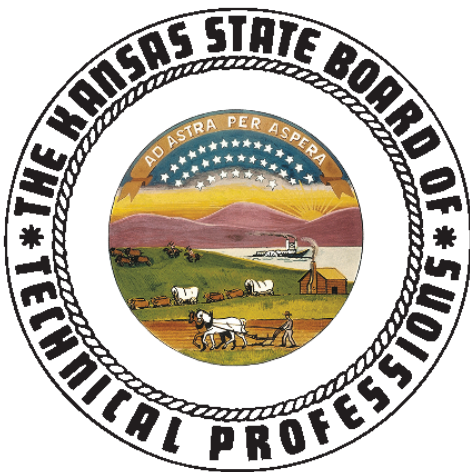

Only licensees can ask to have your “address of record” changed in our system. Address corrections received from returned mail will not be substituted for the last address you provided to the Board Office. License cancellations often occur because of an outdated mailing address.

Do you have a current address listed with the Board Office? Renewal notices are mailed to the address on record. If you have moved or changed jobs since your last renewal and have not notified the Board of your new address, do so now! Be sure to notify the Board office whenever your mailing address needs to be updated. “It’s the law.” K.S.A. 74-7025 states “. . . The licensee shall notify the board in writing of any change of address within 30 days after the date of such change. . . .”

# NCARB Annual Meeting

## 97th NCARB ANNUAL MEETING REPORT

The 97th annual business meeting of the National Council of Architectural Registration Boards was held last June 16 – 18 in Seattle, Washington. Voting delegates from 54 of the 54 Member State Registration Boards attended the meeting. Representing the Kansas State Board of Technical Professions were architect members Wendy Ornelas FAIA and Vince Mancini AIA and Executive Director Shelby Lopez.

KSABTP Architect Board Member Dave Hoffman FAIA, also attended as the 2015-2016 NCARB Treasurer, and NCARB candidate for 2016-2017 Second Vice-President. We are pleased to report that Dave Hoffman FAIA, Wichita, Kansas was elected as NCARB 2016-2017 Second Vice-President. More on the NCARB officer elections for 2016-2017 will follow later in this report.

Here are some highlights of information presented at the meeting:

In 2019 NCARB will celebrate its 100th anniversary. (It is also interesting to note that in 1919 Kansas was one of the original 13 founding members.)

The new Architect Registration Examination, ARE 5.0, that more aligns with current architectural practice will launch November 1, 2016. The current ARE 4.0 will continue to be offered until June 30, 2018.

The Intern Development Program (IDP) has been updated and renamed as the Architectural Experience Program (AXP) to better reflect current architectural practice and the six divisions of the new ARE 5.0.

NCARB by the Number notes:

1. Nearly 41,000 architects hold an NCARB certificate.
2. There are 41,500 candidates working toward licensure and taking the exam or reporting experience hours.
3. 34% of newly licensed are women.

Treasurer Dave Hoffman FAIA noted that fees for member boards and record holders will continue for the sixth year in a row to not require an increase. Fees for the NCARB Certificate and two other NCARB programs will also be reduced.

NCARB President Dennis Ward announced that NCARB will partner AIAS and its “Freedom By Design” program to improve accessible design in underserved communities. At this year’s meeting a design charette was held with AIAS and Member Board participants.

2016 NCARB Resolutions: This year 9 of the 10 resolutions presented to Member Boards were passed. Following is a brief summary of each resolution. The full text of all resolutions can be found on the NCARB website as noted following the summary.

Resolution 01: Implementation of the Mutual Recognition Arrangement with Australia and New Zealand. Although this resolution passed 45-8, complete adoption of this agreement requires 28 of the 54 member board to sign a letter regarding the mutual recognition agreement by December 31, 2016.

Resolution 02: Certification Guidelines Amendment – Revision of the Alternatives to the Education Requirements for Certification. This passed resolution streamlines the alternative to the education requirement for certification while ensuring that each architect has documented the pertinent experience necessary to overcome education deficiencies. Through this program, architects who have been licensed by a jurisdiction without a degree from a NAAB accredited program are provided with the opportunity to meet the educational requirement for certification.

Resolution 03: Certification Guidelines Amendment – Exam Equivalency for ARE 5.0. This passed resolution updates the certification guidelines to reflect modifications to the structure of the Architect Registration Examination as a result of the upcoming release of ARE 5.0.

Resolution 04: Certification Guidelines Amendment – Five Year Rolling Clock and Rolling Clock Extension Policy Updates. This passed resolution recognizes that the ability for member jurisdictions to establish an exam eligibility policy maintained in the NCARB “My Examination” Candidate Management System. This change to the Certification Guidelines will move policy language to the ARE Guidelines.

Resolution 05: NCARB Legislative Guidelines and Model Law/Model Regulations Amendment – Access to the ARE for Students Enrolled in an Integrated Path to Architectural Licensure Option. This passed resolution modifies model law to help guide Member Boards as they modify their regulations to implement IPAL and allow IPAL students to sit for the ARE prior to completing their NAAB accredited degree program.

Resolution 06: NCARB Legislative Guidelines and Model Law/Model Regulations Amendment – Addition of Architect Emeritus Status. This passed resolution to Model Law provides Member Boards with a guide for adopting regulations that are consistent with best practice for regulating the practice of architecture.

Resolution 07: NCARB Legislative Guidelines and Model Law/Model Regulations Amendment – Reference to Military-Trained Applicants. This passed resolution addresses the licensure of military-trained applicants by amending sections of Model Law and Model Regulations.

Resolution 08: NCARB Legislative Guideline and Model Law/Model Regulations and Certification Guidelines Amendments – Updating the name of the Intern Development Program. This passed resolution updates the name of the Intern Development Program (IDP) to the Architectural Experience Program (AXP).

Resolution 09: NCARB Bylaws Amendment – Updating Name of Internship Committee. This passed resolution updates the name of the Internship Committee to “Experience Committee” and the Intern Development Program to the “Architectural Experience Program”.

## Changes to the Kansas State Specific Exam schedule

The Kansas Board will start to offer more dates throughout the year to administer the Kansas State Specific Exam. Look for updates [on our website](#) regarding upcoming dates.

## Emeritus & Inactive Status

**Emeritus status** eliminates the need for retirees to renew their license every two years while allowing them to keep their designation followed with the word “Emeritus.” You must be 60+ years of age and in good standing with the board. Once on Emeritus status, you must reinstate your license to return to practice. The Emeritus status form is available on the website at <http://www.ksbtp.ks.gov/docs/default-source/default-document-library/emeritus-1015.pdf?sfvrsn=2>. **Inactive status** has replaced the retired status previously used. Inactive status does not require continuing education. You still renew every two years and pay the renewal fee. While on Inactive status, you cannot practice your profession in Kansas (including consulting work). To return to practice, you submit the Return to Practice form and provide documentation of continuing education credits to the board. # K.A.R. 66-6-1 Seals and Signatures

Recently, a board committee worked on revisions and updates to KAR 66-6-1 Seals & Signatures. As technology has improved, the committee has looked at ways for the language to reflect current practices. The new updates became effective June 3, 2016.

(a) Each licensee shall obtain a seal of the design approved by the board in compliance with K.S.A. 74-7023, and amendments thereto. The seal may contain an abbreviated form of the licensee's given name or a combination of initials representing the licensee's given name if the surname listed with the board appears on the seal and in the signature. The seal may be a rubber stamp, an embossed seal, or a digital seal.

(b)(1) After the licensee's seal has been applied to any document, the licensee shall apply the licensee's handwritten or authenticated digital signature and the date across the seal. The application of the licensee's seal and signature and the date shall constitute certification that the document on which the seal was applied was created by the licensee or under the licensee's responsible charge.

(2) After a licensee has applied the seal, handwritten or digital signature, and date to a document, that document may be reproduced as necessary for the project in accordance with applicable law.

(3) Any licensee may use a digital signature if the digital signature authentication process meets all of the following requirements: (A) Is unique to the licensee using the digital signature; (B) is able to be verified; (C) is under the sole control of the licensee using the digital signature; and (D) is linked to an electronic document bearing the digital signature in such a manner that the signature is invalidated if any data in the document is altered.

(4) Each transmitted or stored electronic document containing a digital signature shall bear the signature, date of signing, and seal, which shall be a confirmation that the electronic document was not altered after the initial digital signing of the document. If the electronic document is altered, the signature, date, and seal shall be void.

(c)(1) Except as provided in K.S.A. 74-7031, K.S.A. 74-7032, K.S.A. 74-7033, K.S.A. 74-7034, or K.S.A. 74-7042a and amendments thereto, each document, including drawings, technical reports, original land descriptions for the purpose of conveying an interest in real property, records, and papers, shall be sealed, signed, and dated by the licensee who prepared the document or by the licensee who is in responsible charge. The licensee shall seal, sign, and date only work within the licensee's area of licensure and competence. Unless the licensee is in responsible charge, that licensee shall not review or check technical submissions of another licensed professional or unlicensed person and seal the documents as the licensee's own work.

(2) Documents required to be sealed, signed, and dated shall include the following: (A) Any document submitted to any public or governmental agency, a client, or a user for final approval or recording; and (B) each revision to a sealed, signed, and dated document, which shall be identified and sealed, signed, and dated by the licensee responsible for the revision.

(d)(1) The following documents shall be sealed, signed, and dated as specified in this subsection: (A) For a set of drawings, in one of the following ways: (i) On each drawing sheet of a set of drawings; (ii) only on the first sheet of a multisheet set of project drawings if a digital signature authentication process meeting all the requirements in this regulation and capable of digitally linking all drawing sheets to a licensee's area of responsibility is utilized; (iii) in a certification block displaying the seal, signature, and date of each licensee in responsible charge and designating the drawing sheets for which each licensee is responsible, which shall be included on the cover sheet or first drawing sheet of the set of drawings;

(B) for project-specific technical specifications, on the cover sheet or index page. If multiple licensees contribute to these specifications, each licensee shall also designate each part for which that licensee is responsible; (C) for each technical report or survey plat, on the first or last page; (D) for original land descriptions for the purpose of conveying an interest in real property, on the first or last page; (E) for each manufacturer's design document submitted in response to a project's delegated design requirements, including performance specifications or drawings for a specific system or components that are not commonly manufactured items standard for order, and prepared by or under the direct supervision of a Kansas licensee, with the submittal sealed, signed, and dated by the manufacturer's Kansas licensee as specified in paragraph (d)(1)(A) or (B); and (F) for modified standard details or drawings required by a public agency to be incorporated in a project, on the cover sheet or index page of the document.

(2) For multiple seals, each licensee shall affix that individual's seal and signature to the document and shall designate the specific subject matter for which that licensee is responsible, in a note under that licensee's seal or in the title or index sheet indicating the document to which the seal applies.

(e) The documents not required to be sealed, signed, and dated shall include the following: (1) A working drawing or preliminary document, if the working drawing or preliminary document contains a statement in large, bold letters stating "PRELIMINARY, NOT FOR CONSTRUCTION, RECORDING PURPOSES, OR IMPLEMENTATION" or words of comparable meaning; and

(2) published standard details, drawings, or specifications adopted by a municipal, county, or public agency, if incorporated in that agency's own projects. These documents shall be referenced within the project's set of drawings when used. Nothing in this subsection shall relieve a licensee of the duty of professional conduct.

(f)(1) If a licensee who has responsible charge of the work is unavailable to complete the work, a successor licensee may assume responsible charge by performing all professional services, including developing a complete design file with work or design criteria, calculations, code research, and any necessary and appropriate changes to the work, under either of the following conditions: (A) The work is a site adaptation of a standard design plan. (B) The non-professional services, including drafting, are not required to be redone by the successor licensee but clearly and accurately reflect the successor licensee's work.

(2) The successor licensee shall have responsible charge over the work product.

(3) The successor licensee shall be responsible for compliance with this subsection.
